



Terms & Conditions of ECICS x Charge+ Promotion ("Promotion")

1. The Promotion is jointly organised by Charge+ Pte Ltd. ("**Charge+**") and ECICS Limited ("**ECICS**") (collectively, the "**Organisers**"). Eligibility for this promotion is limited to ECICS Private Car Insurance policies covering Electric Vehicles (EVs) only ("**Qualifying Policy**").
2. To qualify for the Promotion:
 - a. You ("**the Policyholder**") must purchase or renew the Qualifying Policy via [ECICS website](#) or through an intermediary from 9th May 2025 to 31st December 2026 (both dates inclusive) ("**Promotion Period**"). The application for, and full insurance premium payment of, the Qualifying Policy must be accepted and received by ECICS during the Promotion Period.
 - b. The Policyholder must either:
 - i. have an active Charge+ account registered under the Policyholder's name, with the insured vehicle under the Qualifying Policy linked to that account; or
 - ii. open a new Charge+ account within two weeks of the Qualifying Policy activation date.
 - c. The Policyholder must be a Singapore Citizen, Permanent Resident, or Foreigner residing in Singapore.
3. Each Qualifying Policy that meets all the eligibility requirements above entitles the Policyholder to select one (1) of the following benefits ("**Benefit**") as follows:

Redemption steps:

- a. Download the Charge+ App
 - b. Sign up for a Charge+ account
 - c. Indicate your chosen redemption option in this [form](#). Do note that the mobile number used to sign up for the Charge+ account must be the same number used to sign up for the Qualifying Policy.
 - d. Your benefit will be activated in your Charge+ account within eight (8) weeks after all eligibility requirements have been fulfilled.
4. The Benefit shall be limited to one redemption per Qualifying Policy. Policyholders with multiple Qualifying Policies may be eligible for multiple redemptions.
 5. The Benefit is non-exchangeable for cash and non-transferrable.
 6. The Benefit is not stackable with other charging benefits or promotion.
